Round Robin draws will be used for U10 & U12.

True double elimination will be used for U14, U16, U18, U21, Senior, Masters and Open Weight divisions with 6 or more competitors. Round robin will be used for divisions with 5 or less.

Competitors must have one of the following:

A white judogi, plus one white and one blue properly fitted belt.

One white and one blue judogi secured with a belt of their appropriate rank colour.

One white/blue reversible judogi secured with a belt of their appropriate rank colour.

Kata results may be used for grading purposes.

The Kata competition will be pre-registration only. Should there be fewer than two teams entered for any kata by October 2nd 2013, entrants will be contacted via E-mail and given the option to change to another Kata or receive a refund.

In order for the opening ceremonies and shiai divisions to commence promptly at 10.00, there will be no formal critique between individual katas. A critique can be given after all teams have competed.
